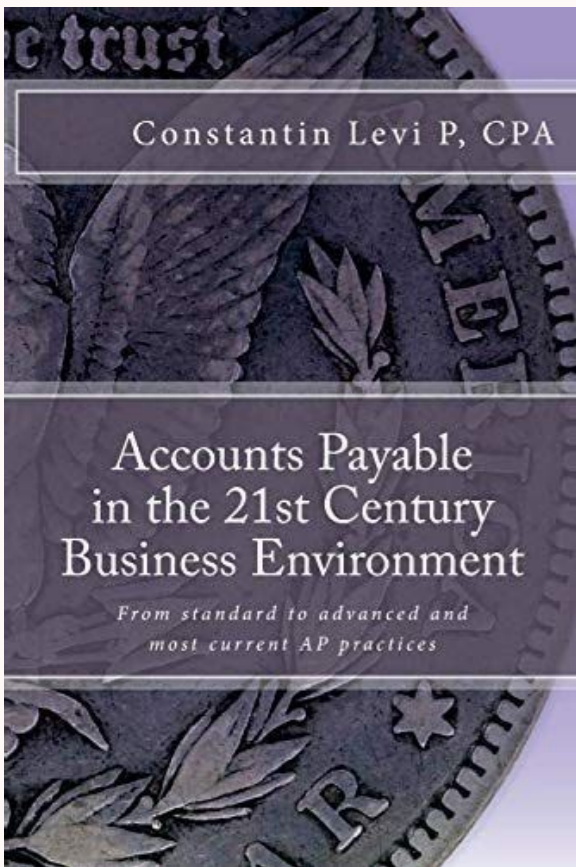

By Chris G. PflumSeveral years ago mybroker recommended the fourth edition (2002) of this book. I really liked that I bought two of McMillan's later publications:McMillan on Options, Second Edition (Wiley Trading) (cited asMcMillan, 2004) and Options for volatile markets: Manage volatility and protection against catastrophic risk (BloombergFinancial) (quoted as McMillan, 2011). I have learned a lot from McMillan's books and I have given them four-star reviews; however, I am a little disappointed in the updates of this 5th edition. Having read the fourth edition and two subsequent publications, I did not find any material significantly new in this fifth edition. About 85% of the book repeats information in the 4th and possibly earlier. The new material includes a chapter on mathematics (pages 447 - 477) and an expanded discussion of volatility (pages 767 - 947). Math applications give a good overview of the theoretical value of an option. If you want to learn how to calculate theoretical values, however, you should also read Options, futures and other derivatives (4th edition) (Hull, 2011). Although new in this book, most of the information about volatility was previously published in McMillan 2004 (pagesand McMillan 2011 (pages 171 - 204). For example, Figures 41-2 (P 872) and Y (p 878) in this book are identical to Figures9.1 and 9.9 in McMillan 2011. Also, much of the volatility-related text and several of the tables in this book are similar tothose in McMillan 2004 and 2011. While one might criticize McMillanfor repackaging the same material in different books, on thepositive side: If you buy this book, you do not need to buy theother two.I am disappointed that this 5th edition still useshypothetical examples, rather than actual trades. Whilehypothetical examples are useful in explaining how to construct aposition or to illustrate a position's sensitivity to individualvariables (i.e., the Greeks: delta, gamma, vega and theta), theyoften do not give one a practical sense of whether the trade wouldbe profitable or even feasible. Moreover, the hypothetical examplesare mathematically rigged to give simple outcomes that do not occurin real trades.Throughout the book McMillan advises his readers toconstruct option positions that are insensitive or "delta-neutral"to changes in the price of the underlying stock (e.g. Chapters 6,11, 12 and 13). In his example of a neutral calendar spread (page215) he buys 7 April 45 calls and sells 8 July 45 calls. The ratioof calls bought to calls sold was calculated from an unrealisticdelta ratio of .7/.8. Actual delta values are expressed to at leastfour decimal places. A neutral position based on deltas rounded tothe nearest tenth would be far from neutral.Chapter 40 explains howto create a position that is neutral with respect to both gamma anddelta and would profit at a specific rate (vega) if impliedvolatility increases or decreases (pages 835 - 836). Theoretically,such a position would be insensitive to changes in the stock'sprice but would profit with changes in implied volatility (IV). Theexample trade sells volatility, i.e. it would profit by \$238.00 forevery 1% drop in IV. To construct such a position for thehypothetical "XYZ" stock, one must buy 100 50 calls, sell 173april 60 calls and short 1,759 shares of Xyz. In my opinion, this is an extremely large position only to make approach when implicit volatility canes. Delta / Gamma neutral propagations in a simulated account using the same mathand that mcmillan us ó in his example. A differential in AppleComputer (AAPL) would benefit if the implicit volatility falls, and another propagation in General Electric (GE) would benefit if the volatility increased increases. Unlike McMillan's example, the only way in which he could arrange close to achieving a neutral delta / gamma position was to co-utter a more modest return of Vega, p. -100.00
